AN ORDINANCE CALLING A SPECIAL ELECTION IN THE CITY OF ALMA, ARKANSAS ON THE QUESTIONS OF ISSUING BONDS UNDER AMENDMENT NO. 62 TO THE CONSTITUTION OF THE STATE OF ARKANSAS FOR THE PURPOSE OF FINANCING THE COSTS OF CAPITAL IMPROVEMENTS; LEVYING A ONE (1%) SALES AND USE TAX FOR THE PURPOSE OF RETIRING SUCH BONDS; AND PRESCRIBING OTHER MATTERS PERTAINING THERETO.

The bonds described below that are approved may be combined into a single issue or may be issued in series from time to time. If the bonds for one or more of the purposes are approved, there will be levied a 1% sales and use tax for the sole purpose of retiring bonds. The net collection of the tax remaining after deduction of administrative charges of the State of Arkansas and required rebates, will be used solely to retire the bonds an obligations of the City with respect thereto. The tax will not go into effect until after the City's existing 1% sales and use tax levied in 2014 for the sole purpose of retiring bonds has expired. The rate of taxation will be 1% even if bonds for more than one purpose are approved.
